I hereby release, discharge, covenant not to sue and agree to hold harmless GFR & SOR and their respective companies, agents, owners, officers, volunteers, participants, employees, insurers and all other person or entities acting in any capacity on their behalf (each considered one of the Releasees herein), from all liability, claims, demands, losses, or damages on account caused or alleged in whole or in part by any act or omission of the Releases in connection with the Retreat activities or otherwise, and further agree that if, despite this release, I or anyone on my behalf makes a claim against any of the Releasees named above, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorneys fees, loss liability, damage or cost which may incur as the result of the claim.
